### **COOKIES POLICY**

United Company Rusal International Public Joint Stock Company and its group of companies (collectively – "**Rusal Group**") uses cookies ("**Cookies**") on its website and through its online services.

This Policy describes what Cookies we use, how you can manage your Cookies, and how to contact us with any questions concerning this Policy or Rusal's Privacy Policy more generally.

This Policy applies to any Rusal website or service that links to this Policy or incorporates it by reference. For any personal information collected through the use of cookies and similar technologies, our Privacy Policy also applies and complements this Policy.

You can manage your consent preferences at any time to accept or reject the use of various categories of cookies, which are not strictly necessary. If you disable cookies and similar technologies, however, some features may not work as intended.

### 1. COOKIES

Cookies are small text files that are stored on your hard drive via your browser. Cookies, by themselves, do not tell us your e-mail address or other personal information unless you choose to provide this information to us by, for example, registering with one of our services.

Cookies store certain information (e.g. your preferred language or site settings) that your browser might retransfer to us upon your next access to our website (depending on the cookie's lifespan). They are used primarily to enable or improve a website's performance and to provide the website's owner with business and marketing information. You can find more information about cookies at: <u>www.allaboutcookies.org</u>.

Some cookies are deleted once you close your internet browser ('session cookies'). 'Persistent cookies' on the other hand stay on your browser for a longer period and are not deleted once you close it, so for example a website you revisit remembers your last visit date. The tables below contain details on the lifespan of the cookies we use.

### 2. COOKIES USED ON THE WEBSITE

We use first party Cookies, i.e. the Cookies sent to your device from a computer or domain managed by us. Specific information regarding the Cookies used on our website is provided below.

#### Cookies we use are strictly necessary Cookies

These are cookies that are required for the operation of our website and use of its features, and therefore cannot be switched off in our systems. The information collected relates to the operation of our website (e.g. indication of cookies acceptance) and enables us to

provide you with the service you have requested. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personal data. These cookies are: used solely for the purpose of carrying out or facilitating the transmission of a communication over an electronic communications network; and strictly necessary to provide you with the function or service you have expressly requested (i.e. if these cookies are disabled, Rusal will not be able to provide you with the function or service you have expressly requested).

Upon first accessing our website, a banner will appear asking you to give us your consent to the use of Cookies. If your consent is given, we will set a Cookie on your computer and the banner is not shown to you anymore for the lifespan of that Cookie. After such period, or if you actively delete the Cookie (e.g., by use of the consent opt-out toggles offered in the table above) the banner will appear again the next time you visit our website and you will again be asked to give your consent.

#### **3. HOW CAN YOU MANAGE COOKIES?**

If you continue to use our website, we will assume that you agree with this Policy and are happy to receive all cookies from our website. Otherwise, you may change your browser's setting, but if you decide to block all cookies, you may not be able to access all or parts of our website.

### 3.1. Removing cookies from your device

You can delete all cookies that are already on your device by clearing the browsing history of your browser. This will remove all cookies from all websites you have visited. However, be aware that you may also lose some saved information (e.g. saved login details, site preferences).

### **3.2.** Blocking cookies

You can set most modern browsers to prevent any cookies being placed on your device, but you may then have to manually adjust some preferences every time your visit a website/page, and some services and functionalities may not work properly at all (e.g. profile logging-in).

## 4. CHANGES TO OUR COOKIE POLICY

We may need to update this Policy in the future and so encourage you to review this Policy periodically to stay informed about how we are using cookies. This Policy was last updated 1 November 2021.

If we change anything important about this Policy we will notify you through a popup on the website for a reasonable length of time prior to and following the change, or another appropriate method.
